- The Invasive Plant Patrol volunteers will be active during August so if you observe people swimming close to canoes near the shoreline please give them wide clearance.

And since there was a lot of discussion about the water level earlier this spring and I thought this might help with understanding. Hopefully, since the lake is now "full" the publishing of the plan will help for next year.
  - The LAA Financial report for last year is enclosed.
  - Your Lake Association has provided money to start testing for phosphorous in the lake water. Phosphorous leaches from dirt roads, and other sources including lawn fertilizers and is food for algae.

Creating berms on the lakeshore helps slow the process so please do low bush plantings along your shoreline and use fertilizer that does not contain phosphorous.

Another important step you can take to help protect the lake is to have a **Lake Smart Evaluation.** 

Ms. Diane Ray, our Lake Smart representative, awards the Lake Smart Sign to Ms. Liz Rothrock, a new resident on the lake and member of the Lake Association. The evaluation, which took place last summer, resulted in suggestions to improve the property. The plants seen along the shoreline are for protecting the lake. Once the plantings were added, Ms. Ray reviewed the property again and awarded the plaque. Lake Anasagunticook was once a leading lake in Maine for Lake Smart participation and awards given. # WHITNEY BROOK TRAIL WALK AND TALK PLANNED

Join the Canton Park and Trail Committee, Oxford County Soil and Water Conservation District and the Maine Forest Service on Friday morning, July 24<sup>th</sup> to enjoy a walk along the Whitney Brook Trail while learning how to identify trees and invasive plant species and about the basics of woodlot management. The informal event will start at 9 A.M. at the Canton Heritage Park (Rt. 108, West of the intersection with Rt. 140) and will proceed along the trail at a leisurely pace giving ample opportunity to ask questions and have them answered before ending by 12 P.M. Constructed in 2008, the 1.7-mile main trail is easy walking through a mixed successional floodplain forest, fields and forested wetland. With numerous tree species, a vernal pool and unfortunately plenty of invasive plant examples, it provides a fine educational and recreational venue.

Merle Ring, the Maine Forest Service District Forester for Oxford County, will lead the discussion on tree identification and woodlot management. Michele Windsor, Project Manager at Oxford County Soil and Water Conservation District will talk about the invasive plant species found in the park and along the trail and methods that may be used to control them. A representative of the Canton Park and Trail Committee will describe how the trail was developed and efforts to maintain it.

The event is being provided free of charge, with advance registration by July 17<sup>th.</sup>.

A rain date is scheduled for July 31<sup>th</sup>. If you wish to register, email <a href="mailto:srgammon@megalink.net">srgammon@megalink.net</a> to provide contact information and number of people attending.

Coffee and donuts will be available before the walk starts.

Please dress appropriately and bring bug spray, water and other needed comfort items.

## Lake Anasagunticook Water Level Management Plan

Revised September 5, 2012

Revised May 1, 2013

The purpose of this plan is to explain how the Anasagunticook Lake Dam will be operated.

October 15th to Ice-In (Fall Drawdown Period)

On or about October 15th, the Dam gates will be gradually opened to draw the lake down to its natural water level of approximately elevation 398 feet above sea level. The drawdown will occur as gradually and consistently as possible with the goal of being complete by ice-in.

Ice-In to Ice-Out (Winter Period)

After the fall drawdown is completed, the Dam gates will be left open and lifted clear of the water. This will ensure the gates do not freeze in place during the winter and will preserve the flood control capacity of the lake during the winter months and into the spring runoff season. The lake will rise above and fall back to its natural level during this period as a result of rainfall and snow melt.

Ice-Out to June 1st (Spring re-fill Period)

On or about April 15th but after the ice is completely clear of the lake, two of the three gates will be closed. On or about May 1st but after the Canton Sewer spring discharge is complete, the remaining gate will be closed in order to start re-filling the lake to its spring level of 402.5 above sea level. During this period it may be necessary to open as many gates as may be required to maintain the target level and reduce the threat of possible flooding.

June 30th to October 15th (Summer/Fall period)

During this time period the water level of the lake will be managed as close as possible to the target level of 402.5 above sea level. In order to do this it may be necessary to raise and lower gates, before, during, and after any potential rainfall in order to try and avoid any lake flooding or downstream flooding.

I have it from reliable sources that summer fun usage in and on the lake is in full swing. There were wonderful displays of fireworks. And I've heard swimming, fishing and boating are being enjoyed by many. Also heard that both bass and trout are being caught. Do they get eaten or returned to the lake? The main dam operating procedure is enclosed in this newsletter. We are still in the planning process for summer activities so please stay tuned. You are encouraged to join the Facebook page,


