Annual Meeting debrief: Positive comments from members and citizens as well as ideas for improving.

Lake Quality Update: Lake has turned over, algae gone, temperatures dropped, one more test before winter; Definition of ice-out: no visible ice from Road shore; do we need to record Ice-in? We will try to accommodate this request by Maine Lakes.

Next Steps of Mitigation Grant: (Jeff Stearns invited): written commitment from Hartford for allocation of Highway funds, steps identified during annual meeting from the grant are still in place, not much to do until early next year.

Supporting individual landowners in watershed mitigation efforts:

Diane has the sheets ready, just need to get the letters out inviting them to reach
out; coordinate with Jeff to ensure priority properties receive mailing – likely first
of the year.

LAA Participation in Canton Bicentennial: ongoing Board conversation as we have agreed to participate – recommendation is \$250 and put out a membership appeal. Diane moved and Mike seconded motion to donate \$250 to the Bicentennial effort.

o Fund raising opportunity – Snack shack on Saturday Aug 7, 2021

Code Enforcement Officer Status: both Canton (Richard Adams) & Hartford (Alan Fernald) have hired new CEO's who will have a period of time to take/pass the required training.

Question on boat/dock removal: Can individuals be compelled to remove boats/docks before winter? Does SLZ require this? How to determine if it is willful negligence or lack of capacity? We will review SLZ and report back.

Town Newsletter updates: Need dates for next submission.

LAA newsletter updates: November Newsletter in the works.
