- John Dyke has reached out to LAA regarding Hartford Beach Cleanup and a dock at the boat launch. Lucille and Jeff along with Harford Selectmen will attend this meeting on Sept 9 to look at what needs to be done regarding erosion. Diane expressed that it has already been determined a dock cannot be put at the boat launch.
- Snail collection event did not happen this year. It's a bit late this year to do this project.
- Waterdown schedule communications. Draw down must coincide with the annual flushing for the sewer dept. Diane will find out from the select board of when this flushing/ draw down will happen.
